01:	Every visitor must read these rules and regulations before starting the routes. The agreement must be sealed and agree with the signature below. For youngsters below the age of 12, supervisors have to fully explain the rules to the child and sign the agreement on behalf of the climber.				
02:	The use of the rope park and the risks associated therewith are at each individual's own responsibility. During the whole stay, safety equiptment must be applied according to instructions given by the rope park staff. The park ist not permanently supervised. Rope park staff is only responsible for instruction, monitoring and assistance.				
03:	The rented equipment (helmet, harness,) must be applied according to instructions and returned unprompted after the rope park visit. Any damages need to be reported to the rope park staff.				
04:	Children as of the age of 4, who are not suffering from physical or mental illnesses presenting a danger to their own or other peoples' health and safety, are admitted to the rope park. Children under the age of 12, need to be accompanied by an adult.				
05:	Objects which may endanger the user or other people are not allowed (jewelry, cell phones, cameras,). Long hair and wide clothing must be tied up. Casual sports wear and shoes with a good profile (sturdy sneakers or walking boots) are recommended.				
06:	Every climber needs to take part at the theoretical and practical security instructions. Should there be any uncertainty, the climber needs to speak up and clarify any questions. All staff instructions and decisions must be strictly followed. The rope park team reserves the right to exclude visitors violating the rope park rules or instructions. The Arosa Tourism Office refuses liability for any damage in case of disregard, evasion or violation of the rules.				
07:	Insurance ist the visitors' responsibility.				
08:	The rope park staff reserves the right to close business for safety-related reasons (fire, storm, bad weather etc.); no entrance fee refund will be granted in this case.				
09:	The place of jurisdiction is Chur, Graubünden. Swiss law is applicable.
